

## Notice of Nomination Meeting

Notice is hereby given that a meeting of the electors of the **Michipicoten First Nation** will be held at the **Michipicoten Band Hall, 107 Hiawatha Drive, Michipicoten First Nation** on **Saturday the 18<sup>th</sup> day of January, 2025**, beginning at **10:00 o'clock a.m.** and lasting for at least three hours to conclude at **1:00 o'clock p.m.** for the purpose of **nominating candidates** for the positions of Chief and Councillors on the Band Council of the said Band, for the next ensuing term. **There are eight (8) Councillor positions and one (1) position for Chief available.**

**The Election will be held at the Michipicoten Band Hall on Saturday the 22<sup>nd</sup> day of March, 2025 from 9:00 o'clock a.m. until 8:00 o'clock p.m.**

Please note that any voter may nominate candidates by using a mail-in nomination form. You can either deliver or mail-in a written nomination and a completed, signed and witnessed voter declaration form to the Electoral Officer before the time set for the nomination meeting OR you may nominate candidates orally at the nomination meeting. Mailed nominations not received by the Electoral Officer before the time set for nomination meeting are void. Also note that any voter may vote by mail-in ballot.

**Please note** that the labour disruption with Canada Post may cause delays in getting the information to you. If you cannot attend the nomination meeting, you may e-mail the Electoral Officer at the e-mail address listed below to have the required forms e-mailed directly or they will be available on the Michipicoten First Nation Website. All **Nomination Forms** must be submitted separately and must be accompanied by a **Mail-in Declaration to Nominate Candidates**. The forms can be e-mailed to the Electoral Officer and a confirmation of receipt will be provided within 48 hours, or through the Nomination Meeting if submitted within 48 hours prior to the Nomination Meeting. Should you not receive a confirmation of receipt, please contact the Electoral Officer directly at the phone number listed below.
